## Promotion Overview

NYFX 100% First Time Deposit Bonus Promotional Program allows all new direct and IB clients to get 100% First Time Deposit Bonus into their live accounts with the minimum deposit amount of \$1,000. The 100% First Time Deposit Bonus Program is a bonus offered by NYFX Financial Services LLC to its clients under the following terms.

## How to claim your No Deposit Bonus

- I. Open “Promotions” page
- II. Click on “Open Live Account” for 100% First Time Deposit Bonus”
- III. Fill and complete the registration form
- IV. Verify your account and make deposit
- IV. Once the verification and deposit process are completed your 100% First Time Deposit Bonus will be credited.

### 1. General terms

1.1 In order for the client to be able to participate in 100% First Time Deposit Bonus Program she/he must first open a live trading account with NYFX and must have completed the age of 18 or the legal age applied in his country of residence.

### 2. Restrictions

- 2.1 No staff members, and/or their relatives of NYFX Financial Services LLC or any associated company, may take part in this promotion.
- 2.2 The bonus program can be applied to one account per client, per IP address and device only. If a client has already applied a bonus program to a live account, no other account can be opened under any circumstances with the bonus program.
- 2.3 Clients cannot switch bonus programs offered by NYFX between their accounts.

### 3. Operating Terms

- 3.1 100% First Time Deposit Bonus can be only claimed by who makes deposit a minimum amount of \$1,000.
- 3.2 Clients can apply for the 100% First Time Deposit Bonus promotions only once.
- 3.3 The bonus can be applied to all account types.
- 3.4 Maximum amount of bonus a client can receive is \$5,000 in total including 50% Redeposit Bonus.
- 3.5 The bonus promotion is 100% of the deposit.
- 3.6 The bonus will be valid for two calendar months from the time that the bonus has been credited to the account.
- 3.7 The bonus cannot be withdrawn but the profit made by bonus is withdrawable.
- 3.8 In the case of withdrawal or internal transfer bonus amount will be removed.

### 4. Trading Terms

- 4.1 The bonus will only be used as a margin of trading.
- 4.2 The trading credit bonus has no effect on stop-out level.
- 4.3 100% First Time Deposit Bonus can't be used in a "drawdown" situation and open positions will be automatically closed if the equity becomes equal or less the credit (Stop Out).

4.4 In the event withdrawals are made before the lots target are met, the bonus will be reversed.

4.5 Max. leverage is 1:400 but the clients can reduce their leverage on SCA.

4.6 Max. profit to be withdrawn is 500\$.

4.7 \$500 is max. amount can be transferred from no deposit bonus account to new account.

4.8 Trades opened via EA will not be taken into consideration.

## 5. Termination of the Promotion

5.1 If NYFX detects that the client has abused the terms of this promotion, NYFX reserves the right to withdraw the trading credit bonus or terminate the client access to the services provided by NYFX.

5.2 NYFX reserves the right to modify or change any of the terms and conditions of this trading credit bonus promotion without client's consent.

5.3 If NYFX detects that the client has abused the terms of this promotion by hedging his positions internally or externally, NYFX reserves the right to withdraw the trading credit bonus or terminate the client access to the services provided by NYFX. Abusement includes hedging, scalping any kind of breach of the system.

5.4 NYFX reserves the right to change promotion terms and promotion period.
