Promotion Overview

NYFX No Deposit Bonus Promotional Program allows all new direct clients to get \$50 bonus on their live accounts and start trading with free tradeable credit. The \$50 No Deposit Bonus Program is a bonus offered by NYFX Financial Services LLC to its Clients under the following terms.

How to claim your No Deposit Bonus

- I. Open “Promotions” page
- II. Click on “Get Bonus” for \$50 No Deposit Bonus”
- III. Fill and complete the registration form
- IV. Verify your account
- IV. Once the verification process is completed your no deposit bonus will be credited.

1. General terms

- 1.1 In order for the client to be able to participate in \$50 No Deposit Bonus program she/he must first open a trading account with NYFX and must have completed the age of 18 or the legal age applied in his country of residence.
- 1.2 If clients meet the requirements stated in the T&C, the clients can claim their profit from trading.

2. Restrictions

- 2.1 No staff members, and/or their relatives of NYFX Financial Services LLC or any associated company, may take part in this promotion.
- 2.2 The bonus program can be applied to one account per client, per IP address and device only. If a client has already applied a bonus program to a live account, no other account can be opened under any circumstances with the bonus program.
- 2.3 No deposit bonus accounts are closed to deposit and internal transfer. If the clients want to make deposit, they need to open a new live account on SCA.
- 2.4 Clients cannot switch bonus programs offered by NYFX between their accounts.

3. Operating Terms

- 3.1 \$50 No Deposit Bonus can be only claimed by verified account holders.
- 3.2 Clients can apply for this bonus promotion only once.
- 3.3 The bonus can be applied only for variable account type.

4. Trading Terms

- 4.1 Profits can be withdrawn after completing 10 round FX and XAUUSD lots in the first two weeks starting from credit entering. Trades opened after second week will not be included into calculation.
- 4.2 Commodities except for XAUUSD, Indices, Shares, Bonds and Cryptos are excluded from calculation.
- 4.3 Only FX pairs and XAUUSD lots will be taken into consideration. Scalped positions (trades closed before 120 seconds) will not be included.
- 4.4 In the event withdrawals are made before the lots target are met, the bonus will be reversed.
- 4.5 Max. leverage is 1:400 but the clients can reduce their leverage on SCA.
- 4.6 Max. profit to be withdrawn is 500\$.
- 4.7 \$500 is max. amount can be transferred from no deposit bonus account to new account.
- 4.8 Trades opened via EA will not be taken into consideration.

5. Termination of the Promotion

5.1 If NYFX detects that the client has abused the terms of this promotion, NYFX reserves the right to withdraw the trading credit bonus or terminate the client access to the services provided by NYFX.

5.2 NYFX reserves the right to modify or change any of the terms and conditions of this trading credit bonus promotion without client's consent.

5.3 If NYFX detects that the client has abused the terms of this promotion by hedging his positions internally or externally, NYFX reserves the right to withdraw the trading credit bonus or terminate the client access to the services provided by NYFX. Abusement includes hedging, scalping any kind of breach of the system.

5.4 NYFX reserves the right to change promotion terms and promotion period.
